NIAGARA TENPIN BOWLING ASSOCIATION TOURNAMENT RULES

1. This is a CTF sanctions tournament. All CTF rules will govern this tournament.
2. Open to all bowlers, 18 years of age and older who are members of the Niagara Tenpin Bowling Association for the 2024-2025 season.
3. Total entry fee must be remitted with entry form to have the entry accepted. No post dated cheques will be accepted. Returned cheques will be subject to prevailing bank service fees.
4. Bowlers arriving late for their assigned shift will start in the frame being bowled and zero shall be scored for each frame missed.
5. Entrants will use their HIGHEST 2023/2024 NTBA/CTF sanctioned average (Standard/Sport/Challenge) based on 21 games or more. If no sanctioned average from 2023/2024 is available, bowlers must use their HIGHEST 2024/2025 NTBA/CTF sanctioned average (Standard/Sport/Challenge) based on 21 games or more, as of December 31, 2024. Proof of average to be supplied by bowler submitting current average. All others will bowl scratch. It is the bowler's responsibility to verify their HIGHEST sanctioned NTBA/CTF average. Refer to rule 319a-3 for specific details.
6. CTF Rule 319a-2 - THE TEN PIN RULE and RULE 319-D AND 319-E SHALL NOT APPLY.
7. Handicap shall be 100% of the difference of the bowler's average and 230.
8. Bowlers shall bowl 3 games on the same pair of lanes.
9. Multiple entries into each event are permitted. Bowlers may enter the doubles event more than once as long as they change their doubles partner. You can only cash once with the same partner. Bowlers may enter teams more than once as long as at least one of the team members are changed from the original team. You can only cash once with the same 4 person team. You can only cash once in singles as well.
10. Bowlers entering All Events must indicate such on a completed entry form along with the additional fee of \$5 prior to bowling the singles event.
11. The first series bowled in each event will count for the All Events total.
12. No substitutions allowed during the game. Emergency cases will be decided by the tournament director.
13. Team captains or their representatives must report to the tournament office 30 minutes prior to squad time for registration and report any changes to their line up.
14. All protests/complaints must be in writing to the Tournament Director within 72 hours.
15. Prize Ratio; All prize money returned 100%. Handicap scores = At least 1 in 7 to cash in each event. First place high scratch will receive \$40.00 in singles portion of the tournament and \$40.00 per team member for the doubles and teams portion of the tournament. Scratch and handicap prize fund determined by the number of entries received in each category.
